Master of International Economics and Finance 2006

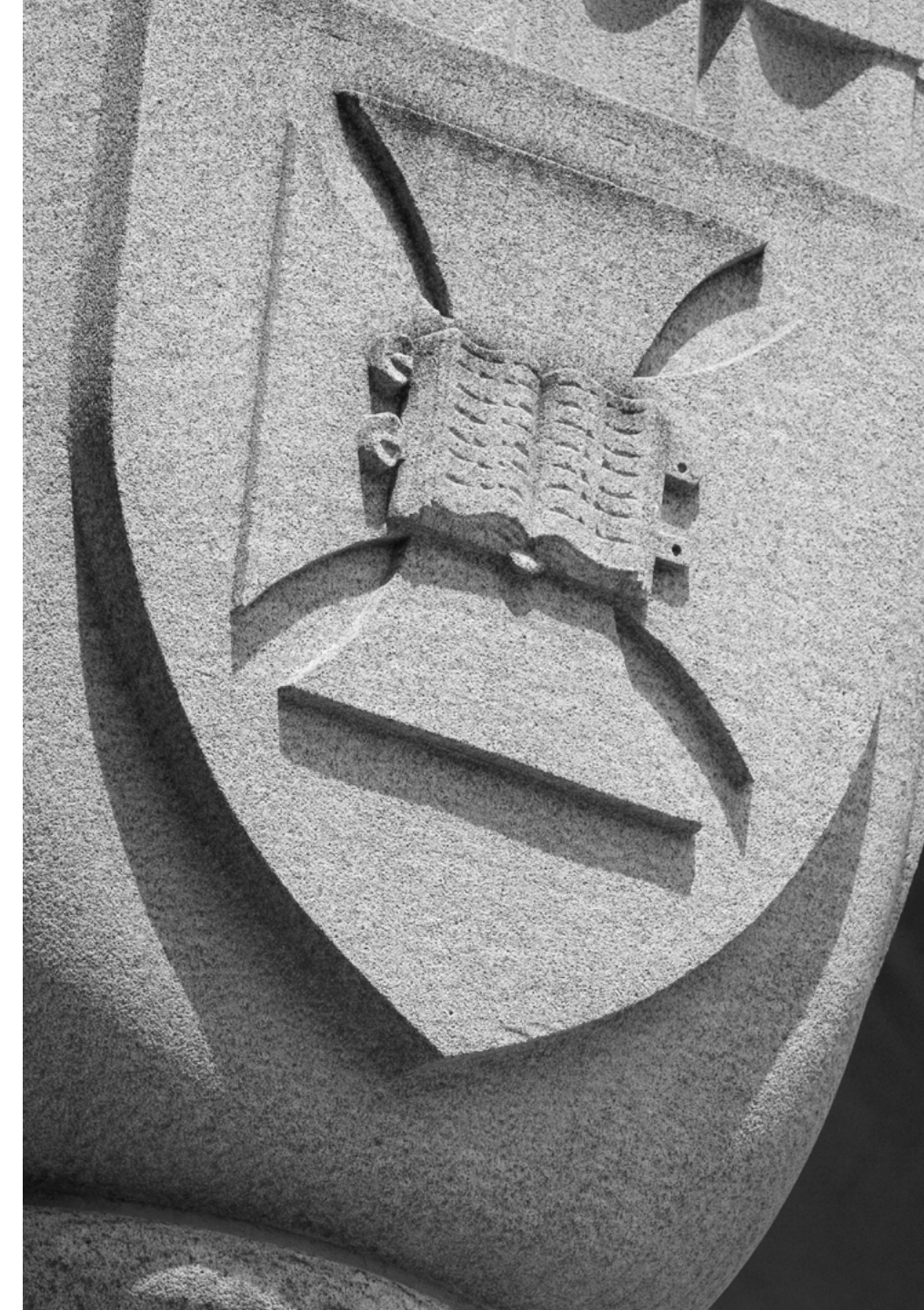


Cameron Bellamy is an endurance athlete, businessman and co-founder of African charity, the Ubunye Challenge.

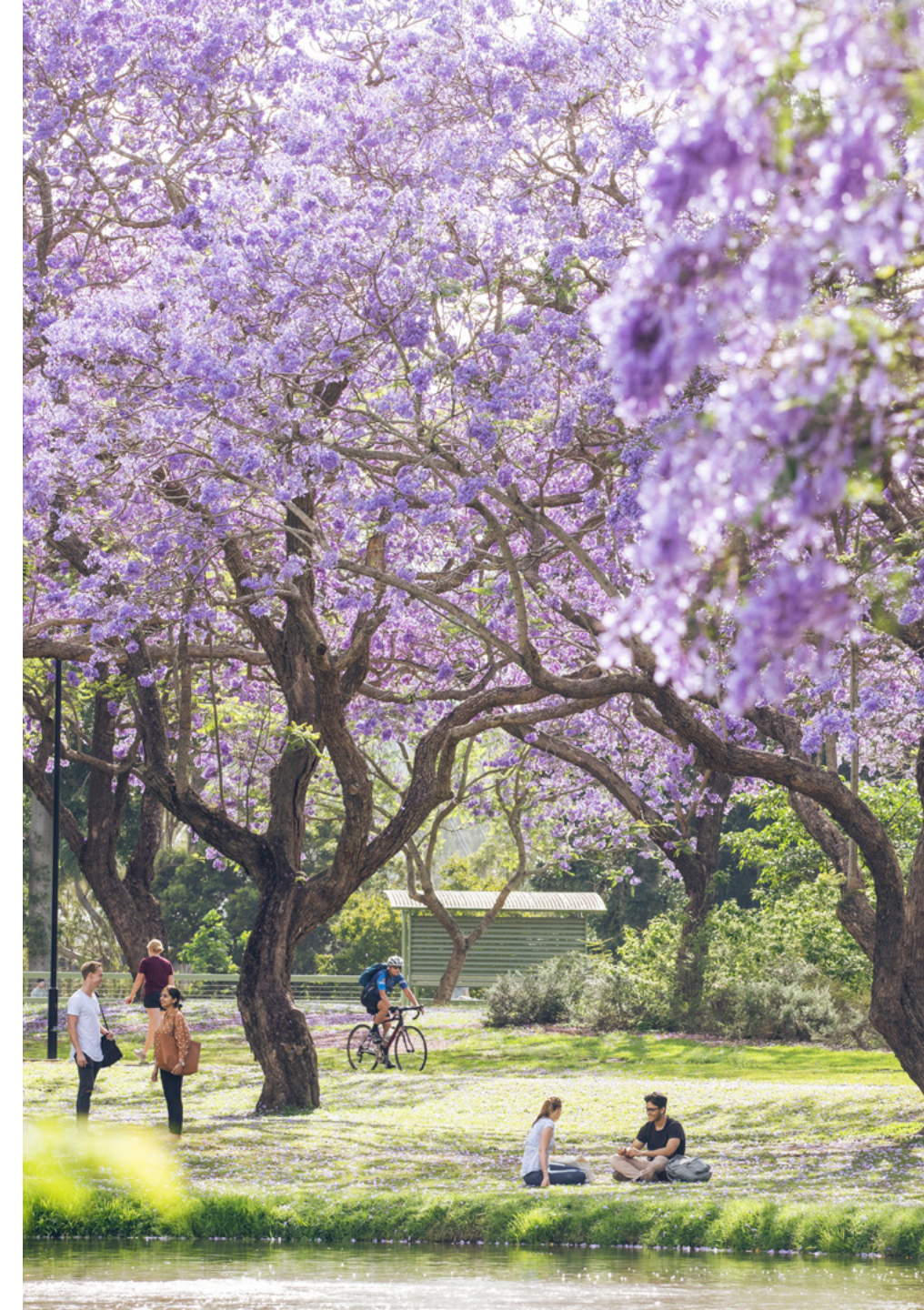


Hoon Sun Loh is a Senior Advisor at Phillip Securities Pte Ltd, and was previously Managing Director for 27 years.

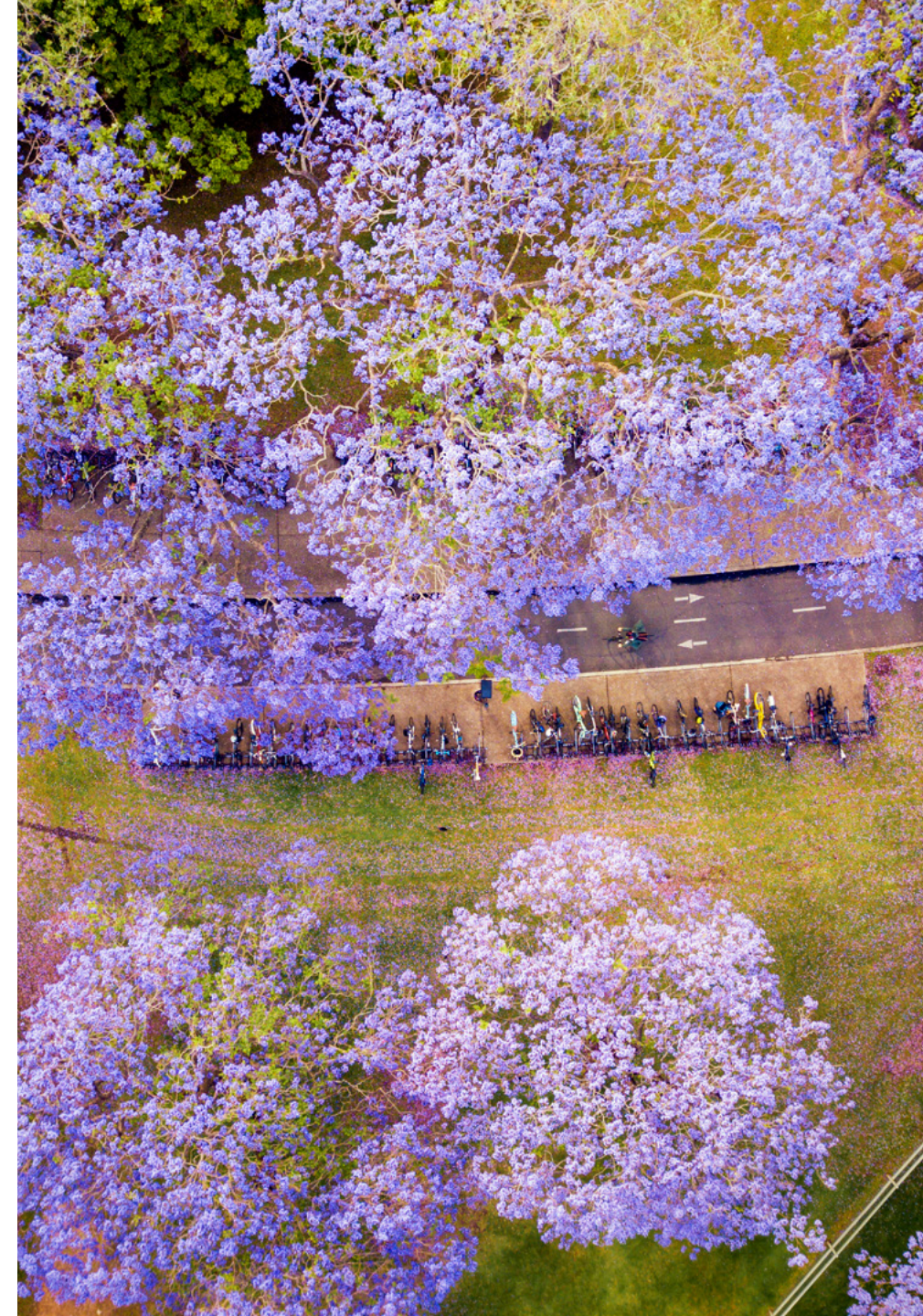

Rowena was admitted to the legal profession in Queensland in 1998, following time as an associate to the Honourable John Macrossan, then Chief Justice of Queensland, and the Honourable Michael McHugh, then Justice of the High Court.

Rowena subsequently worked as a solicitor with the Melbourne office of the Commonwealth Director of Public Prosecutions and received a Masters of Philosophy (Criminology) from the University of Cambridge. In 2017, Orr was selected for the career defining role of senior counsel assisting Commissioner Hayne for the Royal Commission into Misconduct in the Banking, Superannuation and Financial Services Industry.

His Excellency Taneti Maamau is the President of the Republic of Kiribati.

He is an I-Kiribati politician hailing from the island of Onotoa in the Southern Kiribati.

Taneti became the 5th President of Kiribati after successfully winning the 2016 Presidential Election, leading his opposition party of Tobwaan Kiribati to a major victory to take over administration, and bringing a change to Government after 12 years since 2003.

He won the election in March 2016 with a major landslide victory winning the largest majority of votes of 19,883 (60%) against his two rivals from the ruling party with 12,764 votes (38%) and the other with only 482 votes (2%).





# Ric Battellino

Ric Battellino was Deputy Governor of the Reserve Bank of Australia (RBA) from 14 February 2007 to 13 February 2012.

He was also, at that time, Deputy Chairman of the Reserve Bank Board, and Chairman of the Reserve Bank's Risk Management Committee.

He was employed by the Reserve Bank since graduating from UQ with honours in economics in 1973.

In earlier roles with the RBA, Ric oversaw the Bank's operations in domestic and foreign exchange markets – including implementation of domestic monetary policy, foreign exchange intervention and management of international reserves.

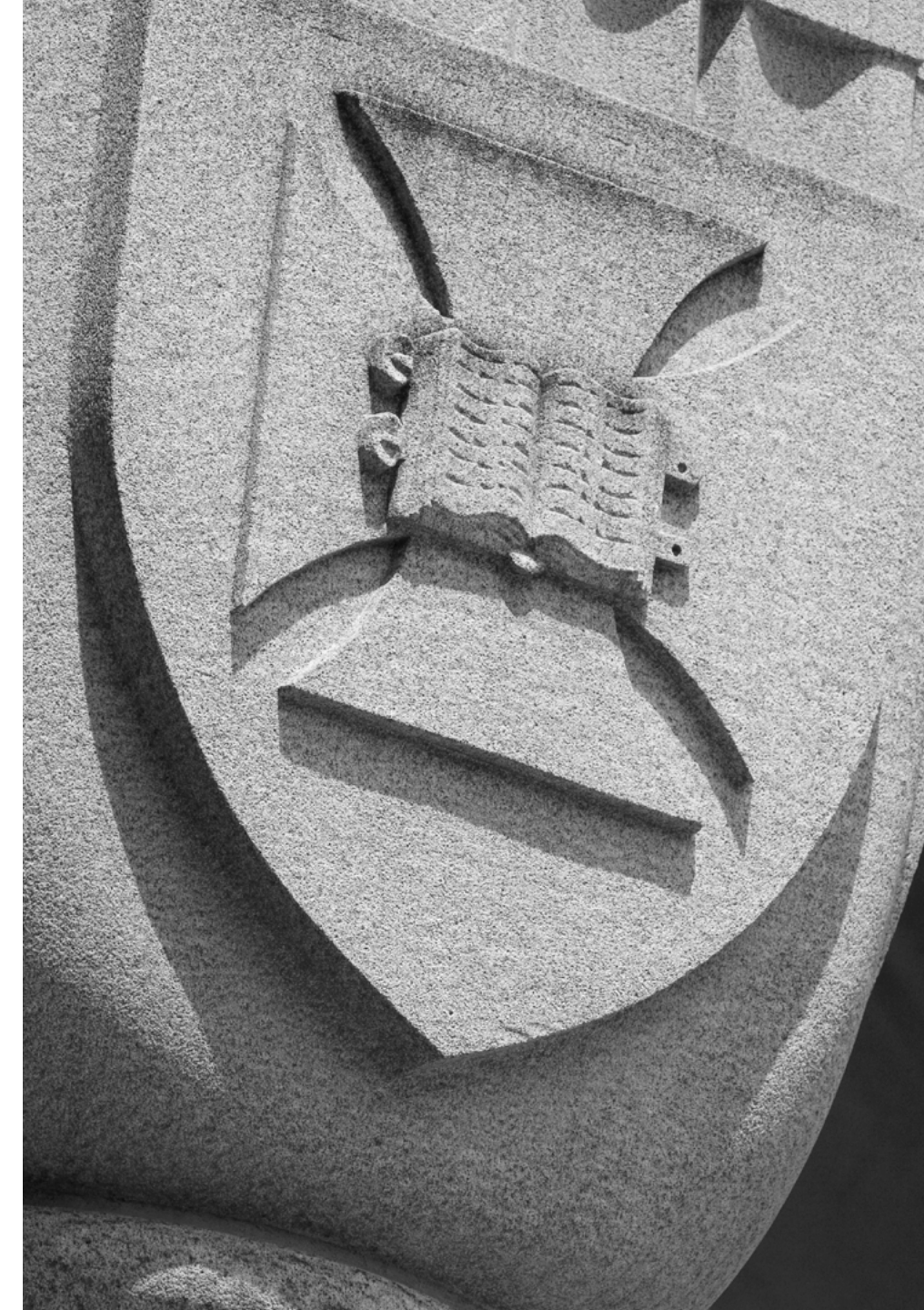

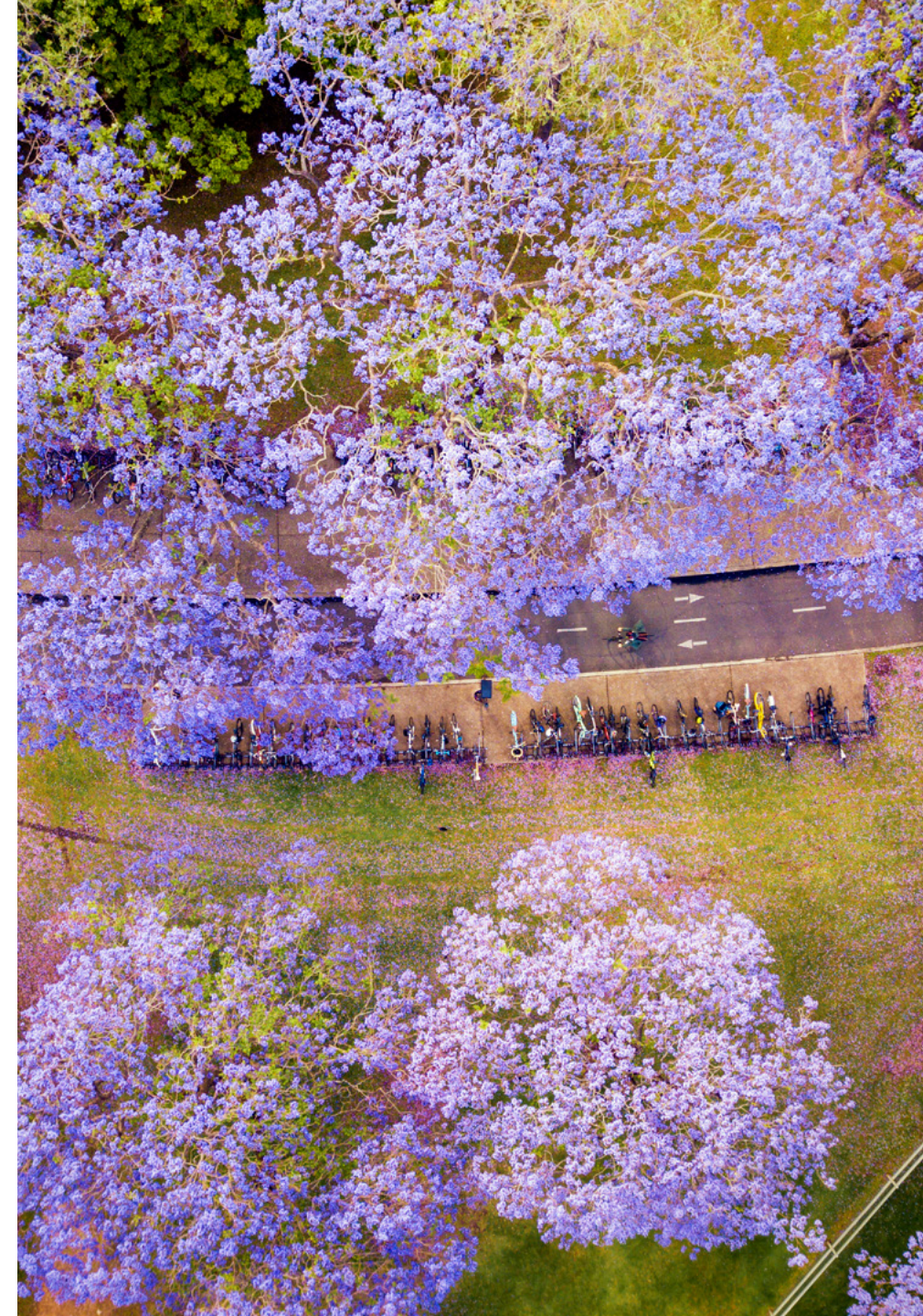
