## Introductory overview

Associate Professor Mohammad Alauddin's academic career in Australia spans four decades, initially as an RHD student and part-time academic at the University of Adelaide and the University of Newcastle, and more importantly, since 1988 as a full-time academic in two best-known Australian Schools of Economics, University of Melbourne, and The University of Queensland.

Associate Professor Alauddin has sustained an active research agenda in environment, development and productivity growth focusing on agriculture. This includes publishing papers in all the top journals in the field of development economics including Economic Development & Cultural Change; Journal of Development Economics; Journal of Development Studies; World Development. I have also published in all three top journals in environmental economics (Journal of Environmental Economics & Management; Ecological Economics; and Environmental & Resource Economics). My research has added new dimensions to measurement of agricultural crop water productivity involving panel data.

To date, he has authored/co-authored (edited) (a) more than 70 refereed journal articles including three in A<sup>\*</sup>; 19 in A; 18 in B; (b) four books with leading international publishers [Macmillan 1991, 1998 (A1); Edward Elgar 2001 (A1); Macmillan 1999 (A3)]; (c) 16 refereed book chapters; (d) one edited conference monograph [1996]; and (e) one research monograph [A2]. This research includes publishing with the leading economists at UQ (Professor Clem Tisdell, ARC Laureate Fellow (currently Vice Chancellor's Senior Research Fellow) John Quiggin, and Professor Prasada Rao), International Food Policy Research Institute (IFPRI) economist Derek Headey, International Water Management Institute (IWMI) senior researchers Upali Amarasinghe and Bharat Sharma) and University of California, San Diego (Adjunct Professor Dale Squires).

Dr Alauddin has garnered international reputation as a researcher in terms of views of the leading authorities in the field and citations in quality mainstream and multidisciplinary journals. Much of his research has been cited at least a decade after they were first published, in some cases at least two and half decades after publication typifying enduring quality and relevance of my works. His first book (Alauddin & Tisdell, 1991) remains a definitive piece on the Green Revolution in agriculture even nearly three years after publication (the latest citation in 2020).

Additionally, Dr Alauddin led three competitive research grants - one Australian Research Council (ARC) Discovery (\$208,000, 2006-2008) and 2 Australian Centre for International Agricultural Research (ACIAR) funded (\$156,000, 2011-2012 and \$91,631, 1996-1999). I have also been associated with five other highly regarded and competitive research grants funded by ARC (large grant 25,000, 1992-1993, ACIAR (\$150,000 - 2010-2011; (\$150,000 - 2014-2015) and International Labour Organization (ILO) (20,000 - 1991; \$32,000 - 2003-2004).

Associate Professor Alauddin's expertise as a researcher of repute is valued by the academic and professional community within and outside Australia as evidenced by invitations to serve as an external examiner for a range of universities both on a national and international stage. Top-level journals in the field invite him to review papers on a regular basis. He has also served as a panel member for review of program of World Fish Centre.

Dr Alauddin has taught both core and specialist areas at undergraduate and postgraduate levels, including microeconomic theory and policy, managerial economics, statistics, and ecological economics. He has most recently taught the postgraduate development economics, and research methods in economics courses. Dr Alauddin always challenged his perceptions in teaching and experimented with alternative teaching approaches with a view to providing an intellectual challenge and fostering independent thinking within students to improve learning outcomes and their employability. This belief stimulated him into undertaking a second PhD in Education. His own research on higher education and the works of leaders in the field including John Biggs and William Becker have underpinned his teaching philosophy.

Associate Professor Alauddin added a new dimension to his teaching role by demonstrating evidence of fostering synergy between teaching and research and promoting scholarship in teaching and learning in higher education. For two decades he has sustained an active research agenda in this field as evidenced by 14 papers on various aspects of teaching and learning in higher education (including statistics anxiety). His education PhD, publications and on-going interest in this vital area have added a new dimension to his role as a university academic by demonstrating evidence of fostering synergy between teaching and research and promoting scholarship in teaching and learning in higher education.

Dr Alauddin's teaching approach has been well received by students and he consistently received student ratings, at 4 or higher on a 5-point scale when combined over more than one semester and across courses.

Associate Professor Alauddin successfully supervised four PhD students (as principal advisor) and seven students as associate advisor. In addition, he has successfully supervised 6 Honours, 10 coursework masters, 9 postgraduate diploma, 1 MBA theses and projects in a range of research areas including mathematics and differing socio-economic contexts.
