PROGRAM GUIDELINES

You must complete:

- 6 units for Part A
- 2 units for Part B

If Exemptions apply for Part A courses, students are to undertake electives from Part B. With Head of School approval, a student may include 2 units for a level 7 course towards Part B.

The following is a suggested study plan only. There may be other ways to plan your progression through this program.

The study plan ensures pre-requisite courses are completed first. Students should not attempt courses where they have not completed the UQ pre-requisite(s) or an alternative comparable course completed at undergraduate or postgraduate level.

Not all courses are offered every semester and/or every year. Check courses offerings prior to enrolling.
