PROGRAM GUIDELINES

You must complete:

- (a) 20 units from the [MDevEcon \(#24\) Course list](#), comprising -
 - i. 16 units for Part A; and
 - ii. 4 units from Part B, excluding any courses counted towards rule (b)(i); and
- (b) 12 units from the [MEconPP \(#24\) Course list](#), comprising -
 - i. 8 units from Part A; excluding any courses counted towards rule (a)(i); and
 - ii. 4 units from Part B, excluding any courses counted towards rule (a)(i) or (a)(ii).

Refer to the [MDevEcon/MEconPP Program Rules](#) for further information.

- If exemptions apply for ECON7110, ECON7021, ECON7310 or ECON7950, students are to undertake electives from Part B of either the MDevEcon or MEconPP course list.
- If exemptions apply for courses specific to Part A of the MDevEcon, students are to undertake electives from Part B of the MDevEcon.
- If exemptions apply for courses specific to Part A of the MEconPP, students are to undertake electives from Part B of the MEconPP.

The following is a suggested study plan only. There may be other ways to plan your progression through this program.

The study plan ensures pre-requisite courses are completed first. Students should not attempt courses where they have not completed the UQ pre-requisite(s) or an alternative comparable course completed at undergraduate or postgraduate level.

Students who wish to complete the #4 Thesis course as a Part B elective as ECON7930 (single semester) or ECON7933 (year-long commencing in semester 1) or ECON7934 (year-long commencing in Semester 2) should complete both pre-requisite courses prior to enrolling, i.e. ECON7310 Elements of Econometrics and ECON7950 Research Methods in Economics. Further information is available from the Course Profile (ECP).

Not all courses are offered every semester and/or every year. Check courses offerings prior to enrolling.
