Overview of the Centre (including Mission Statement)

The main purpose of the Centre is to provide a focal point for research, consultancy and training in efficiency and productivity analysis in Australia and the Asia/Pacific Region.

The principal aims and objectives of the Centre are to undertake theoretical and applied research, develop useful end-user-driven short courses and workshops and to develop computer software for use by private and public sector organizations. Specific objectives are:

- to assess and develop methods for the measurement of productivity, efficiency and economic performance;
- to apply these methods to assess the performance of firms, industries and sectors within the domestic and international economies;
- to conduct research directed towards explaining and interpreting patterns of productivity and economic growth across nations;
- to conduct ex post assessment of the effects of microeconomic reform and deregulation on productivity and efficiency;
- to provide technical advice to private and public sector and international organizations on efficiency and productivity measurement; and
- to offer short courses and workshops to researchers, managers and policy analysts from various sectors of industry and government.

- Continue to produce high quality journal publications.
- Continue to provide high quality supervision to our PhD students and encourage them to produce journal publications from their research.
- Continue to attract high profile visitors and good quality PhD students to work on projects undertaken by CEPA staff.

- Deliver at least two three-day short-courses on introductory and/or advanced productivity and efficiency analysis methods.

Performance against agreed objectives:

In 2013 CEPA staff:

- produced seventeen journal publications, fourteen conference papers, nine working papers, one monograph, one edited book and three book chapters.
- were involved in the supervision of five PhD students;
- hosted thirteen international visitors;
- applied for external research funding through the ARC (unsuccessfully)
- presented three short courses and a number of seminars;
- ran two workshops,
- served in journal editorial roles and made various other contributions to the profession.
